The sealed tenders, separately for each motor vehicle, superscripted "**DISPOSAL OF CONDEMNED VEHICLE**" at the top left, should reach the Office of the Commissioner of Central Excise & Service Tax, No.1, Williams Road, Cantonment, Thiruchchirappalli - 620 001, *on or before 18/03/2011 @ 1700 hrs.* Submission of photocopy of the **PAN CARD** is mandatory along with the tenders.

3. The tenderers should clearly mention their name, complete postal address and the registration number of the motor vehicle sought, both on the tender sheet as well as on the envelope and deposit a sum of **Rs. 2500/- (Rupees Two thousand five hundred only)** by **Demand Draft** in favour of **the Pay and Accounts Officer, Central Excise & Customs, Thiruchchirappalli** for *each* motor car as **Earnest Money Deposit (EMD)**.. The tenders will be opened on **23/03/2010 @ 1100 hrs** in the presence of the available tenderers at the time. The EMD is refundable to unsuccessful tenderers after completion of the tender opening process.

4. Successful tenderer(s) shall be required to pay 25% of the tender value, for each motor car, in cash on the spot itself. On acceptance of the tender(s) by the Commissioner of Central Excise, Thiruchchirappalli, the balance amount has to be paid within 7 (seven) days from the date of opening the tenders, failing which, the EMD and the 25% of the tender value paid shall stand forfeited to the Govt. of India. The successful tenderer(s) should take delivery of the Motor.car (s) only on full and final settlement of the accepted price. Thereafter leaving the car(s) in the office premises will be at the tenderer's own risk.
