In case it is not possible for the nominated member to personally attend the meeting due to unforeseen and unavoidable circumstances, another representative of the organization may attend the meeting with the permission of the Chairman.

4. The functions of the Committee are purely advisory in nature relating to resolving the procedural or other difficulties and problems of general nature so as to enable the administration to take steps to resolve them.

5. The Committee will ordinarily meet once in a quarter at such place, as the Chairman may decide.

6. Members of the Committee shall be entitled to travelling allowances admissible under the Orders of the Government of India, Ministry of Finance in force.
